Where can I purchase a Toyota Certified Used Vehicle?

Toyota Certified Used Vehicles are sold exclusively through participating Toyota Dealers. To find your nearest Toyota Certified Used Vehicle Dealer visit www.toyota.com.au/certified

How long is the Statutory Warranty once in effect?

Statutory warranties vary by the State or Territory in which the used vehicle is sold. All States and Territories legislate a 3 month/5,000 kilometre statutory warranty for some specified used vehicles (excluding Tasmania, where 3 months/3,000 kilometre warranty applies). This warranty starts from the day of delivery of the vehicle and will cover most items on a car relating to safety, reliability and roadworthiness. Please ask your Toyota Used Vehicle Sales Consultant for details of the statutory warranties applicable in your State or Territory.

How long is the Toyota Roadside Assist once in effect?

1 year of Toyota Roadside Assist expires 12 months from the date of Toyota Certified Used Vehicle delivery.

How do I tell if my used vehicle is still eligible for Toyota Service Advantage capped price services?
